As a cooperative, Virginia Credit Union operates solely for the benefit of its members, not outside stockholders. Earnings are returned to members through helpful services, attractive rates, lower fees, and free financial education programs and resources.

Members receive personal attention through a fullservice call center, branches, and online services. Online and mobile banking, network ATMs worldwide, and thousands of shared credit union branches provide convenient access.

Founded in 1928, Virginia Credit Union serves a broad and diverse field of membership that makes it easy to join. The membership includes employees and retirees of Virginia state and local governments and public schools, students at state-supported colleges and universities, as well as employees and members of hundreds of other companies and groups.

In addition, individuals who live, work or attend school in the Cities of Richmond, Petersburg, Hopewell and Fredericksburg, and in Buckingham, Cumberland, Nottoway and Prince Edward Counties are also among the many who can join and benefit.
